I, the renter of this rental equipment, assume and understand that river tubing can be HAZARDOUS, and that rocks, logs, bridges, plants, animals, other people, other water craft, exposure to the elements, variations in water depth and speed of current, along with other structures and equipment, and many other hazards or obstacles exist in the river environment. In using the rental equipment or any facilities or vehicles related thereto such dangers are recognized and accepted whether they are marked or unmarked. River tubing can be a strenuous and physically demanding activity. It requires walking, bending, lifting, paddling, swimming, and awareness of the outdoor environment. I realize that slips, falls, flips, and other accidents do occur and serious injuries or death may result and I assume full responsibility for these risks. I further realize that personal property such as wallets, watches, keys, phones, glasses, food, and other items brought along on the trip may be damaged or lost during the course of the activity and I assume responsibility for repairing or replacing such items if damaged or lost. I acknowledge that alcohol consumption is not recommended and that consuming alcohol while participating in this activity will affect my judgment, response time, physical ability, and coordination and could increase my chances of being involved in an accident or being affected by the natural elements. I further acknowledge that life vests are always recommended and provided and if I choose not to wear it I do so at my own risk against the advice and policies of Let's Go Tubing, Inc. "IN CONSIDERATION FOR THIS RENTAL AND ANY USE OF THE FACILITIES, VEHICLES, OR ENVIRONMENT RELATED TO THE USE OF THIS EQUIPMENT, I HEREBY RELEASE HOLD HARMLESS AND INDEMNIFY LET'S GO TUBING, INC. Season Pass Rental Terms & Conditions

***** Read before signing *****

1. Life Vests are always recommended and included with each rental. Participants under 6 are required to wear a Life Vest at all times.
2. The marked beach is the required take out. You are responsible for paddling into the beach at the end. Do not float beyond this point due to hazardous rapids or limited access downriver.
3. By using the equipment you acknowledge you have read and understood the **Release of Liability** (above) and the **Safety & Navigation Instructions**.
4. **Tubes must be returned by closing.** Equipment not returned on the same day will be charged an additional full day rental for each day they are not returned.
5. In the event that equipment is lost, stolen, or forgotten, you will be required to pay the replacement cost of each item. (replacement costs are listed with the cashier)
6. The rental equipment is for the undersigned season pass holder only. If the tube or other equipment is used by someone other than yourself, you, the pass holder, assume any and all liability associated with the unauthorized use and will forfeit your season pass for the remainder of the season.
7. You must present your season pass with picture ID each time you come tubing.
8. If your pass is lost or stolen you must report it immediately. You can purchase a replacement pass for \$15.
9. If your pass is used by another person it will be revoked and you have to purchase another pass at full price or purchase daily tickets.
10. Season Pass holders must abide by all the rental terms and conditions listed or risk revocation of pass.
